As we move along into the new year, we need to remind everyone to be vigilant about our security. Just because we are a gated community does not mean that we are immune to crime.

During the final few months of 2018, there were a few instances where the Seminole County Sheriff's Office responded to The Cove.

- A house on Reagan Trail was broken into in late November.
- In early December, SCSO chased four individuals out of Egret's Landing, across Old Lake Mary Road, and through our subdivision.
 Several homeowners on Night Breeze Lane found evidence of these teens in their yards and on their video surveillance cameras.
- In late December, there were reports of suspicious vehicles following delivery trucks into the community.

While we can never stop all crime, we can make our homes and our community safer:

- Lock your doors and windows, even when you are home.
- If you park your vehicles in your driveway or on the streets, do not leave your keys in the car and make sure to lock your doors.
- On garbage days, make sure to bring your garbage cans and recycle bins inside after collection. Leaving them on the sidewalk for an extra day or two can signal to burglars that you are not home.
 Besides, it's against HOA bylaws to leave them out.
- Similarly, newspapers and packages left in the driveway or on your stoop can signal that no one is home.
- Do not share your gate code with anyone you do not know, especially people that do not live here.
- If you see something, say something. Find someone in the
 neighborhood that you've never seen here before? Ask them if you
 can help. If they're soliciting or simply do not live here, simply call
 911. Be safe; you don't need to confront them.

Be responsible. Additionally, please do not feed or interact with the sand cranes. These magnificent birds are a part of our community, and have no fear of humans or our vehicles. Same with all other creatures.

FRONT GATE CODES

Recently, several homeowners have experienced issues with their codes to access the front gate. For security, we had to eliminate one gate code, and at least a half dozen people were affected.
